Step 1:

Be sure to circle all applicable [bracketed] items.

Step 2:

Include a one page (700 words maximum) description of what you wish to share with a media representative or producer from the television, radio, film, print, or Internet industry for them to consider you as an interview subject for their production. You may include copies only (no originals) of your best one or two supporting documents (a news clipping, DVD, etc.) **Do NOT send original items as they will not be returned to you.**

Step 3:

Send this form, story material and a check or money order **made payable to "The Research Department"** in the amount of **\$59.95** (USD) for a 12 month membership in the registry. Within two weeks of receiving your submission, we will mail or email you either a Letter of Acceptance or we will return your payment
